LIMITED WARRANTY: Wahl Professional Animal, a division of Wahl Clipper Corporation (“Wahl”) warrants that its Wahl Professional Animal Division Products (“Products”) will be free from manufacturing defects for one (1) year from the original date of purchase or receipt as a gift. Because Wahl cannot control the quality of products sold by unauthorized sellers, this warranty applies only to Products purchased from Wahl or one of its authorized sellers, unless otherwise prohibited by law. Wahl reserves the right to reject warranty claims for Products purchased from unauthorized sellers, including unauthorized Internet sites. If your Wahl product fails to operate satisfactorily within one (1) year from the date of original purchase or receipt as a gift, once received Wahl will at our option repair or replace it and return it to you **FREE OF CHARGE**. Our warranty does not cover blades, which are parts that are subject to normal wear.

Please print out the completed Warranty/Repair Request Form and mail it alongside your product(s) and a copy of your receipt or other proof of purchase to Wahl Service Center, 3001 N. Locust St., Sterling, Illinois 61081. Please note that you are responsible for costs incurred in mailing your product, proof of purchase, and completed Warranty/Repair Request Form to Wahl.. If, upon inspection, Wahl determines that the Product has a defect covered by this warranty, Wahl will repair or replace the Product, in Wahl’s discretion, depending on the nature of the defect. Products out of warranty will be repaired at our standard repair charges.

The warranty is void and no repair or replacement will be made under this warranty or otherwise if:

- 1) The Product is modified in any manner;

- 2) The Product is repaired by anyone other than Wahl Clipper Corporation;
- 3) The Product has been subjected to misuse or unreasonable use;
- 4) The damage is the result of normal wear and tear;
- 5) The damage is the result of negligence; or
- 6) The Product was purchased from an unauthorized seller.

This warranty gives you specific legal rights and you may also have other rights which vary from State to State. No other written express warranty is given and there are no warranties which extend beyond those stated herein. Any implied warranty including any warranty of merchantability or fitness for a particular purpose, which may arise from purchase or use, is limited in duration to the one-year period provided in this express warranty. Some States do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. Under no circumstances shall Wahl be liable for any special, incidental, or consequential damages based upon use of unauthorized attachments, breach of this warranty, breach of contract, or strict liability.
